Our August Evidence Centre seminar saw plenty of discussion around family harm initiatives developed by Police and discussion of the results of the 2018 NZ Crime and Victims

Survey from the Ministry of Justice.

Our next seminar and the eleventh in the series will feature two presentations, one from our colleagues at Inland Revenue - Te Tari Taake discussing the impact of early intervention in child support to improve financial wellbeing for families; the other presenting findings from Oranga Tamariki research on supporting teen parents. #### **OUR RECENT PUBLICATIONS**

#### **TEEN PARENTS EVIDENCE BRIEF**

The Teen Parents Evidence Brief provides up-to-date evidence from New Zealand and international literature about effective support for teenage parents, their children and family or whānau.

It includes information about support services and interventions currently in place in New Zealand, indicators of their effectiveness, and outcomes for teenage parents and children engaged with those services.

International literature shows supportive interventions for teenage parents should be early, comprehensive, wraparound, and strengths-based. Read more from the report findings here.

### **CAREGIVER SATISFACTION SURVEY**

How Well is Oranga Tamariki Supporting Its Caregivers presents the findings of a quantitative survey among the population of

4,000 caregivers and respite caregivers who provide care to children in the care of Oranga Tamariki.

We believe that in the right environment, with the right people surrounding and nurturing them, children can and should flourish. We need to ensure their caregivers have what they need to provide stable, loving homes for tamariki and to identify areas where change is needed. The survey provides a baseline to allow the effects of legislative and practice changes to be monitored. Read the report here.

#### THE EDUCATIONAL EXPERIENCES OF CHILDREN IN CARE

The Expert Advisory Panel (2015) reported that children and young people who came into the care of Child, Youth and Family (CYF) had high rates of educational disengagement and underachievement.

Oranga Tamariki further explored these experiences and outcomes through a qualitative study of children and young people's experiences, a review of New Zealand government data, and a literature scan of national and international research in a suite of three research reports titled Experiences of Education for Children in Care.

Key findings from the research indicate that children and young people in care can often experience exclusion and disciplinary action, which appears to increase with age. These children also often find academic achievement difficult, experience learning difficulties and frequent changes of school, both of which can negatively impact on their learning. Data shows that early intervention with children and young people in care can be beneficial to their educational outcomes. Find the reports here.

## MEET THE TEAM: VALMAI COPELAND



Valmai is one of the Principal Advisors in the Evidence Centre. She grew up in Tokoroa, heart of the Timberlands, in the days when it had the highest average income in New Zealand. The town was a mix of nationalities from around the world. Valmai received a degree in Technology from Massey University, majoring in statistics and computing. She accepted her first job with Statistics NZ in the Christchurch office because she had never been to the South Island. After five years she moved

to Wellington for a 'short stay' in 1980 and has been here ever since. Highlights of her spell in Stats NZ were leading the Time Use pilot study to measure the contribution of unpaid work to the New Zealand economy, and developing an index of real disposable income. Her next career move was to Inland Revenue to work in their evaluation unit. Major projects included developing methods to measure the compliance costs of tax payers, and the evaluation of Working for Families.

Eighteen months ago Valmai joined Oranga Tamariki and reunited with many of her Working for Families colleagues. She has become immersed in a number of projects, with the measurement of harm to children in care providing an understanding of the hard end of our work.

Valmai is interested in all things textile, belongs to a guilt

guild, and knits and dressmakes for relaxation. She also loves

the sea and wants to visit all of our Pacific neighbours. On a recent break from work she combined all these enthusiasms by assisting in running sewing workshops for Ni-Vanuatu women in four different locations on Efate, the main island of Vanuatu.

will allow us to regularly and systemically hear from our stakeholders. The report on findings from the survey of caregivers has recently been published and work has started on other stakeholder surveys.

It is a privilege to see the wide range of transformative activities that Oranga Tamariki is undertaking, and to work with the clever and compassionate people who are leading these changes. I am very fortunate to be able to say I love my job, and believe in the value of the work we do.
